(b) an act or omission not in good faith that constitutes a breach of duty of the director to the Corporation or an act or omission that involves intentional misconduct or a knowing violation of the law;


(c) a transaction from which the director receives an improper benefit, whether or not the benefit resulted from an action taken within the scope of the director's office; or

(d) an act or omission for which the liability of a director is expressly provided by an applicable statute.

This Article Nine shall be deemed to incorporate by reference any future amendments to applicable law that permit further limitations on or eliminations of the personal liability of directors.

Any repeal or modification of all or part of this Article Nine shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.
